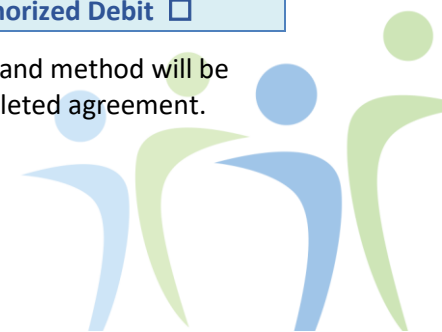

# 2024-2025 Tuition Agreement

## Terms of Payment

1. This Tuition Agreement between Montessori School of Calgary (MSofC) and the parent/legal guardian guarantees full annual tuition for the 2024-2025 school year. The parent or legal guardian assumes all financial responsibility for the child enrolled in Montessori School of Calgary.
2. Montessori School of Calgary is a non-profit organization and depends on prompt payment of tuition and fees for operating expenses (hereinafter referred to as the "fees"). Should fees remain outstanding after the due date, the school reserves the right to cancel enrolment and/or take whatever reasonable action is deemed necessary to collect its fees.
3. This Tuition Agreement must be signed and returned along with all required enrolment forms. The non-refundable deposit must be paid in full by April 1, 2024 to guarantee your child's enrolment with the Montessori School of Calgary. For late enrolment after April 1, the non-refundable deposit will be considered due on/before the 1st of the month following confirmation of admission (to secure your child's enrolment).
4. NSF cheques will be assessed a \$25 administration fee.
5. No reduction or remission will be given in cases of temporary absence or withdrawal. Late payment charge of 2% will be applied after thirty (30) days.
6. There is no refund of paid fees or cancellation of fee obligations if you withdraw your child from the program.
7. MSofC may at any time, in its sole discretion, discontinue a student's enrolment if it determines that the student's behavior is detrimental to the well-being of other students or staff; or the student or any parent or guardian repeatedly fails to follow policies and procedures as established by the Montessori School of Calgary.
8. The Tuition Agreement may be terminated by a student's parent/legal guardian if a written notice of withdrawal is mailed, emailed or delivered by hand to the school office. Such notice must indicate your child's last day of attendance. All fees are non-refundable/non-transferable.
9. This Tuition Agreement shall be construed and enforced in accordance with, and the rights of the parties shall be governed by the laws of the Province of Alberta and federal laws of Canada applicable therein. Each of the parties hereto irrevocably attorns to the jurisdiction of the courts of the Province of Alberta in the judicial district of the City of Calgary.
